FOUR YEAR OLD PRE-KINDERGARTEN PROGRAM – PK4

TUITION: The following annual rates and due dates are in effect for the 2012-2013 school year

SUPPORT RATE: \$5,600 per PK4 Student

SIBLING DISCOUNT RATE: \$4,100 per PK4 Student
A discount of **\$1,500** will be given to PK4 students who have siblings enrolled in our K-8 program.

Support Rates are for parishioners who contributed \$850 or more in their **Church Envelopes** during the **2011** calendar year based on regular weekly contributions at Sunday Mass. Support Rate tuition is based on the time period during which the family was living in the parish.

NON-SUPPORT RATE: \$11,200 per PK4 Student

APPLICATION FEE: \$200 per PK4 Student
Application Fees are non-refundable and are required at the time of application.

Monthly tuition bills will be for one tenth of the annual rate and will be billed for the months of August 2012 through May 2013. **Tuition for the month of August will be billed on June 1, 2012 and will be due by June 10, 2012.** The acceptance of any child is not final until this advance tuition payment is received. Tuition for the months of September 2012 through May 2013 will be billed on the first and due by the tenth of each month. Tuition payments are not refundable.

SCREENING FEE: A \$25 non-refundable fee will be charged for students applying for Pre-Kindergarten.

ACADEMIC FEE: \$225 per PK4 student.
Academic fees are payable at the time of acceptance.

Academic Fees cover:

1. Consumable workbooks and other resources. Mandated supplies by School Pak are not included in the above fees.
2. Sleep mats.
3. Includes a technology fee which is escrowed for technological advances.
4. Materials for Computer, Music, Physical Education, and Science Lab. (Voluntary extra-curricular activities are not included).
5. Media Center, Accelerated Reader program and resources.
6. Annual Standardization Tests and other testing programs.
7. Home and School Association fee.
8. Premium for student's Accident Insurance during the school day.
9. School website (www.saintgreg.org), Edline and School Reach.
10. Classroom dues and School Family Directory.

Please note: Pre-Kindergarten is a separate entity from the K-8 school with separate tuition and student application fees.

CHURCH SUPPORT CONTRIBUTION – Tuition Support/Non-support

It is the desire of your Pastor that all school families support St. Gregory Church regularly and realistically and thus qualify for the lower tuition rates. Moreover, it is recognized that many of our families can and should contribute substantially more than the minimum annual amount of \$850 in the **Church envelopes** during the calendar year 2011 as specified in the tuition rate schedule.

PAST DUE ACCOUNTS

Tuition is "past due" if not paid by the 10th of each month. A five day grace period is given before a late fee of \$25 is charged to all past due accounts. **All difficulties regarding tuition payments should be referred to the Parish Manager by calling 954-473-6261.**
